Job Description

ABOUT THE ORGANIZATION

The California Conference for Equality and Justice (CCEJ) is dedicated to eliminating bias, bigotry and racism through education, conflict resolution and advocacy. Since 1963, CCEJ has worked to transform communities to end discrimination, oppression and injustice. Our programs raise awareness, heal conflicts and bridge differences. They operate at two distinct levels: at the interpersonal level, changing hearts and minds with youth, adults and community leaders; and at the systemic level through policy shifts and engaging community to advocate for structural change. CCEJ works in many contexts where differences and conflict exist and can be resolved—in schools, businesses and neighborhoods. Embracing differences and striving for understanding and inclusivity, CCEJ seeks to build a unified, peaceful and safe Southern California, with justice for all.

OUR VALUES

CCEJ uses an anti-oppression and liberatory framework to guide our work and organizational culture. Within this are the following guiding principles:

- **No one is disposable:** Everyone is important and we need everyone in this work.
- **Forgiveness and redemption are critical parts of justice.**
- **The United States was built on oppression:** Changing how it fundamentally works is the only way to truly end oppression for all.
- **No one is free until all of us are free:** Oppression and justice for all of us are interconnected.
- **Justice can only be achieved together:** Working for justice demands that we build solidarity and work to be allies.
- **Another world is possible:** Oppression can and will end through our collective work.
- **Restorative choices are always available to us:** Responding to conflict in ways that build accountability and trust is always a choice we can make.
- **Healing work is justice work:** In order for us to work for the long run, we must center self-care, healing and building resilience in our process.

CCEJ's work is focused on building individual and collective power to end structural forms of oppression and cannot happen without all of us. For this reason, CCEJ strongly encourages and welcomes applications from Black people, Indigenous people, LGBTQI+ people, women, people of color, people from working class backgrounds, religious minorities, and people with disabilities.

ABOUT THE TEAM

Iluminar: Training and Coaching for Justice is CCEJ's interdisciplinary team that provides experiential and innovative training, coaching, strategic planning, facilitation, and other technical assistance services rooted in Racial Justice and Restorative Justice for schools, workplaces, colleges and universities, families, and community settings. Inspired by the power of light in many forms to shift our perspective and understanding - especially around topics that we might prefer stay unexamined - Iluminar specializes in training and coaching services focused on building cultures of real equity and healthy conflict. In 2020, Iluminar provided trainings and coaching for over 50 contract partners, serving hundreds of individuals. Iluminar also produces CCEJ's podcast series - *Whatchu Know about RJ?* The

series features interviews, storytelling, and experimental audio formats from Restorative Justice practitioners to highlight the interdisciplinary spectrum of Restorative Justice facilitation and theory, with topics such as: creativity, communication, relationships, and justice. CCEJ has two open Trainer & Coach positions on this team, and will be hiring two people.

POSITION OVERVIEW

CCEJ seeks a seasoned person that is values-driven, adaptive, self-directed, and passionate about providing individuals, teams, and organizations with the highest quality of services, to join our team as a Trainer & Coach. The Trainer & Coach plays a critical role in the successful implementation of CCEJ's fee-for service training and technical assistance services for adult learners in a wide-range of settings, including K-12 schools, corporations, colleges and universities, parents/caregivers, juvenile justice agencies, workplaces, systems of care, community organizations, and nonprofit organizations.

Reporting to the Director of Illuminar: Training and Coaching for Justice, the Trainer & Coach is responsible for providing training and technical assistance in Restorative Justice and anti-oppression frameworks and practices to partners contracting CCEJ's services. This position requires working collaboratively with various stakeholders to shift organizational cultures, policies, and practices. The ideal candidate has a working knowledge of Restorative Justice, intersectional analysis of oppression and justice, adult learning theory, curriculum development, and motivational coaching.

This is a full-time exempt position that will include frequent work on evenings and weekends.

If you were the Trainer & Coach right now, you would potentially be:

- Working on prepping Racial Justice training curriculum for contract partners this upcoming fall
- Planning the upcoming *illume: Restorative Culture Shift Institute*, CCEJ's training program for individual Restorative Justice practitioners
- Helping to update tools for Restorative Justice implementation for schools and districts
- Beginning to plan for a safe return to in-person trainings and services in early 2022

CCEJ is operating in a hybrid work model that includes a combination of virtual and in-person office work during the ongoing COVID-19 pandemic. We have not yet returned to facilitating in-person training and coaching. The Trainer & Coach, like all CCEJ staff, will work in this hybrid structure while we monitor guidance from public health officials about what is safe.

RESPONSIBILITIES INCLUDE:

Training & Consulting Services Planning and Delivery (70%)

- Work with department staff in developing and implementing standardized core series of trainings focused on establishing and sustaining changes in culture, policies, and practices through anti-oppression and Restorative Justice frameworks
- Work with department staff in developing and updating technical assistance tools (activities, worksheets, planning tools, circle guides, etc.) focused on supporting core trainings
- Co-develop, implement and review all assessment and measurement instruments for evaluating current/future programming where appropriate and incorporating data into future program design
- Co-design, pilot, deliver, and evaluate new curricula and tools to meet emerging needs of current and potential fee-for-service partners

- Maintain up-to-date awareness of the latest research, evaluation and literature to keep implementation of all programs at the highest quality possible
- Translate emerging practices and research into adaptable trainings and tools for use with contract partners
- Conduct periodic survey of past, current, and potential future training/technical assistance partners to assess emerging needs and interests
- As needed for in-person trainings plan logistics such as venue rental, material prep, meal ordering & delivery, for trainings

Partnership Development (20%)

- Support Director of Illuminar in prospecting, marketing, and partnership exploration to businesses, colleges & universities, K-12 schools, government agencies, and other potential fee-for-service partners
- Maintain a strong and ongoing relationship with current and past fee-for-services partners
- Conduct presentations to potential partners on training and technical assistance services as needed

Organizational Responsibilities (10%)

- Manage assigned duties within approved budget; take timely, appropriate action to ensure expenditures do not exceed revenues.
- Support CCEJ's efforts in grant writing, marketing, public relations, event coordination and financial management as necessary.

QUALIFICATIONS

The successful candidate will demonstrate the following:

Required

- At least three years of experience in designing, implementing, and evaluating training programs focused on anti-oppression education or Restorative Justice
- Extensive experience in designing, implementing, and evaluating training, facilitation, and dialogue for varied groups, including youth, educators, and community members
- At least four years of experience working in social justice field with intersectional lens of power and liberation
- Demonstrated experience in fee-for-service partnerships with a focus on businesses, colleges & universities, and K-12 schools
- Demonstrated experience working in a respectful and collaborative manner with marginalized communities targeted by the systemic inequities, such as People of Color, LGBTQIA+ communities, youth, people with disabilities, religious minorities, and immigrant communities
- Proficient understanding of Google Suite (including Gmail, Docs, Forms, Slides, Sheets, Jamboard, and Google Sites), Zoom, Microsoft Office Suite, and Adobe Acrobat
- Strong ability to be self-motivated in executing work responsibilities
- Highly organized, proactive and detail-oriented, with the ability to effectively and efficiently manage deadlines and multiple tasks
- Ability and willingness to regularly work weekends and evenings
- Must have valid California Driver's License, reliable transportation and proof of insurance.

Preferred

- Experience with using Restorative Justice practices in workplace and/or school settings;
- Bilingual in English and Spanish or Khmer
- Video editing or podcast editing/hosting experience (e.g. Audacity, Podomatic, etc.)

SALARY & BENEFITS

This position is full time, non-exempt. Salary range is \$59,000 - \$62,000. Compensation is based on experience. Benefits include medical, dental, vision, Life/ADD/LTD insurance, 403b retirement matching and generous vacation, sick and wellness accrual, as well as funded professional development.

1. As we emerge out of the COVID-19 pandemic, CCEJ is focused on deepening the alignment of our work. One of the ways we will be activating our commitment to justice is by being more direct about the impact of oppression and values around liberation that guide us. We are looking for future team members who are excited about joining us in our journey of speaking truth to power in all of our programming.

2. CCEJ is a values-driven organization where we consistently reflect on and seek to activate our core values in decision-making, program delivery, relationships, and other key parts of our organizational culture.
 - *What values are central to your work and how do you activate them day-to-day?*
3. Working in a nonprofit organization offers the opportunity to directly address structural problems in society that create inequities and strip away people's human dignity. CCEJ's pursuit of our mission often requires periods of intensive work to reach our goals.
